WE ALSO OFFER LOW COST VACCINATIONS, FLEA AND TICK MEDICINE, HEARTWORM TESTING, MICROCHIPPING AND LIMITED ADDITIONAL VETERINARY SERVICES THROUGH OUR WELLNESS CLINIC. IN 2015 WE PERFORMED 10,861 SURGERIES, AND HAD A TOTAL OF 6,060 WELLNESS CLINIC VISITS. OF THE TOTAL SURGERIES PERFORMED, 2,751 WERE COMMUNITY CATS. 211 FREE RABIES VACCINES AND 189 FREE MICROCHIPS WERE GIVEN OUT AS PART OF ONE OF OUR OUTREACH PROGRAMS.
