OUR MAIN EMPHASIS IN 2017 WAS OUR LOW COST SPAY/NEUTER CLINIC. THE CLINIC IS OPEN TO THE PUBLIC AND OFFERS HIGH QUALITY, HIGH VOLUME, LOW COST SPAY AND NEUTER SURGERIES TO DOGS AND CATS. WE ALSO OFFER LOW COST VACCINATIONS, FLEA AND TICK MEDICINE, HEARTWORM TESTING, MICROCHIPPING AND LIMITED ADDITIONAL VETERINARY SERVICES THROUGH OUR WELLNESS CLINIC. IN 2017 WE PERFORMED 9,740 SURGERIES, AND HAD A TOTAL OF 4,816 WELLNESS CLINIC VISITS. OF THE TOTAL SURGERIES PERFORMED, 5,500 WERE SHELTER PETS AND 2,640 WERE COMMUNITY CATS.
